

1. **ELIGIBILITY:** InRoads LIVE App Contest ("Contest") is open to legal residents of the United States, who are 18 years of age or older at the time of entry. Employees, contractors, directors and officers of, InRoads Federal Credit Union, ("Sponsor") and their immediate family members (spouse, parent, child, sibling and their respective spouses, regardless of where they reside) and household members, whether or not related, are not eligible to participate. Void outside the U.S. and where prohibited by law. Subject to all applicable federal, state and local laws and regulations. Participation constitutes entrant's full and unconditional agreement to these Official Rules and Sponsor's and judges' decisions, which are final and binding on all matters related to the Contest. Entries must be received during the Contest Period to be eligible. The server hosting the Contest application is the official timekeeping device for the Contest.

3. **HOW TO ENTER:** Speak with an InRoads LIVE representative using the InRoads LIVE app. Must provide name, member number and phone number to representative. Must be InRoads member in good standing at time of drawing. Maximum of one entry per person per entry week (Monday - Friday, 08:00 AM – 06:00 PM PST, Saturday, 09:00 AM - 03:00 PM PST). Winners may win multiple weeks. Entries must be received no later than official Contest Period.

By participating, you agree to indemnify and hold Sponsor harmless from any and all claims, demands, causes of action and judgments (including attorney's fees, court costs and expert's fees) arising out of relating to any breach by you of these Official Rules. By participating, you agree to these Official Rules and the decisions of the Sponsor and the Contest Administrator, which are final and binding in all respects. Use of any automated program or device to enter will result in disqualification. Sponsor is not responsible for lost, late, incomplete, invalid, unintelligible or misdirected entries, which will be disqualified.

4. **JUDGING/WINNER SELECTION:** Based on the entries received in the Contest Period, one (1) potential winner will be selected in a random drawing from among all eligible entries received on or about the following Monday at or around 10:00AM PST by Sponsor, whose decisions are final and binding in all respects.

address, mailing address and/or telephone number of entrants.

GENERAL CONDITIONS: Sponsor reserves the right to cancel, suspend and/or modify the Contest if any fraud, virus or other technical problem corrupts the administration, security, or proper execution of the Contest, as determined by Sponsor in its sole discretion. In the event of cancellation, Sponsor will award the prizes from among eligible entries received prior to cancellation, in accordance with the selection processes described above. Sponsor reserves the right in its sole discretion to disqualify any individual it finds to be tampering with the entry process or the operation of the Contest or to be acting in violation of these Official Rules or in an unsportsmanlike or disruptive manner. Any attempt by any person to deliberately undermine the legitimate operation of the Contest may be a violation of criminal and civil law, and, should such an attempt be made, Sponsor reserves the right to seek damages from any such person to the fullest extent permitted by law. Sponsor's failure to enforce any term of these Official Rules shall not constitute a waiver of that provision. Sponsor is also not responsible for any damage to any participant's computer system/software related to or resulting from participation or downloading any materials in this Contest.

11. ARBITRATION/CHOICE OF LAW: Except where prohibited, entrants agree that (1) any and all disputes, claims, and causes of action arising out of or connected with this Contest, or any prize awarded, or the determination of the winner shall be resolved individually, without resort to any form of class action, and exclusively by arbitration pursuant to the Rules of the American Arbitration Association, then effective, and (2) any and all claims, judgments and awards shall be limited to actual out-of-pocket costs incurred, including costs associated with entering this Contest but in no event attorney's fees; and (3) under no circumstances will entrant be permitted to obtain awards for and entrant hereby waives all rights to claim punitive, incidental and consequential damages and any other damages, other than for actual out-of-pocket expenses, and any and all rights to have damages multiplied or otherwise increased.
