

## **InRoads Federal Credit Union 2021 Digital Scholarship Terms and Conditions**

As part of our ongoing effort to invest in the future of our community, InRoads Federal Credit Union proudly offers a college scholarship program for our members. Five scholarships will be awarded in the amount of \$1,000 each.

### **Eligibility Requirements:**

1. Applicant must be a member of InRoads Credit Union with accounts in good standing at the time of application and scholarship award announcement.
2. Applicant must be a graduating high school senior.
3. Applicant must have a grade-point average (GPA) of 3.0 or higher.
4. Applicant must attend an accredited college or university for the 2021-2022 school year.

### **Selection Criteria**

Digital submission – Content relevance & creativity

### **Submission Information:**

1. Applicant must submit a completed online application at [www.inroadscu.org/scholarship](http://www.inroadscu.org/scholarship).
2. Applicant must submit one of the following types of digital media content to answer this question: "Why should your friends and family join a Credit Union?"
  - a. Video 30 seconds to 2 minutes in length. Videos must be uploaded to YouTube and URL link to video must be supplied on scholarship application.
  - b. Three to five original social media posts. Screenshots of posts must be submitted with scholarship application.
  - c. Three to five original memes. Screenshots of posted memes must be submitted with scholarship application.
3. Videos, social media posts or memes must be posted with the hashtag #InRoadsScholarship.
4. An official high school transcript showing total cumulative GPA must be sent directly from the school in a sealed, stamped envelope to: InRoads Credit Union, Scholarship Committee, P.O. Box 537, St. Helens, OR 97051.

### **Deadline:**

Completed application and digital submission must be submitted by March 31, 2021. Official transcript must be postmarked by April 9, 2021.
