

As part of our ongoing effort to invest in the future of our community, InRoads Federal Credit Union proudly offers a college scholarship program for our members. Five (5) scholarships will be awarded in the amount of \$1,000 each.

### Eligibility Requirements:

1. Applicant must be a member of InRoads Credit Union with accounts in good standing at the time of application and scholarship award announcement.
2. Applicant must be a graduating high school senior.
3. Applicant must have a grade-point average (GPA) of 3.0 or higher.
4. Applicant must attend an accredited college or university for the 2022-2023 school year.

### Selection Criteria:

Digital submission – Content relevance & creativity

### Submission Information:

- Applicant must submit a completed online application at [inroadscu.org/scholarship](http://inroadscu.org/scholarship).
- Applicant must submit one of the following types of digital media content answering the question: *Why do credit unions appeal to your generation?*
  - Three to five original TikTok videos, posted with the hashtag *#InRoadsScholarship*. Videos need to be downloaded and submitted with scholarship application.
  - Three to five original social media posts or memes, posted with the hashtag *#InRoadsScholarship*. Screenshots of posts must be submitted with scholarship application.
  - Video 30 seconds to 2 minutes in length, posted with the hashtag *#InRoadsScholarship*. Videos must be uploaded to YouTube and URL link to video must be supplied on scholarship application.
- An official high school transcript showing total cumulative GPA must be sent directly from the school in a sealed, stamped envelope to: InRoads Credit Union, Scholarship Committee, P.O. Box 537, St. Helens, OR 97051.

### Deadline:

Completed application and digital submission must be submitted by March 31, 2022. Official transcript must be postmarked by April 9, 2022.
