

INTEREST RATES AND INTEREST CHARGES	
Annual Percentage Rate (APR) for Purchases	12.99 % to 18.00 % based on your creditworthiness when you open the Account. This rate will vary with the market based on the Prime Rate.
Annual Percentage Rate (APR) for Cash Advances	14.99 % to 18.00 % based on your creditworthiness when you open the Account. This rate will vary with the market based on the Prime Rate.
Annual Percentage Rate (APR) for Balance Transfers	12.99 % to 18.00 % based on your creditworthiness when you open the Account. This rate will vary with the market based on the Prime Rate.
Penalty APR and When it Applies	18% This APR may be applied to your account if your minimum monthly payment is more than 60 days late.  How long will the Penalty APR Apply?
