

As part of our ongoing effort to invest in the future of our community, InRoads Federal Credit Union proudly offers a college scholarship program for our members. Two (2) scholarships will be awarded in the amount of \$2,500 each.

**Eligibility Requirements:**

1. Applicant must be a member of InRoads Credit Union with accounts in good standing at the time of application and scholarship award announcement.
2. Applicant must be a graduating high school senior.
3. Applicant must have a grade-point average (GPA) of 3.0 or higher.
4. Applicant must attend an accredited college or university for the 2024-2025 school year.

**Selection Criteria:**

Digital submission – Content relevance & creativity

**Submission Information:**

- Applicant must submit a completed online application at [inroadscu.org/scholarship](http://inroadscu.org/scholarship).
- An official high school transcript showing total cumulative GPA must be sent directly from the school in a sealed, stamped envelope to: InRoads Credit Union, Scholarship Committee, P.O. Box 537, St. Helens, OR 97051.
- Applicant must create one (1) two-minute video or three (3) 30-second videos that are designed to *influence their friends to open an account at InRoads Credit Union*. Videos should be posted publicly to social media (i.e. TikTok, Facebook, Instagram, or YouTube) with the hashtag #InRoadsScholarship. The video(s) must remain publicly posted until at least June 1, 2024. Once video(s) have been created and posted, the video(s) or URLs must be included in the online application.

**Deadline:**

Completed application and video(s) must be submitted by March 31, 2024. Official transcript must be postmarked by April 10, 2024. Incomplete applications or videos that do not meet the above posted submission requirements will not be considered.
