

## Happy Holidays with Santa Sweepstakes - Official Rules

SWEEPSTAKES PERIOD: Sweepstakes period begins on or around December 16, 2024 at or around 9:00:00 AM PST and ends on or around December 20, 2024 at or around 06:00:00 PM PST ("Sweepstakes Period"). Entries must be received during the Sweepstakes Period to be eligible. The server hosting the Sweepstakes application is the official timekeeping device for the Sweepstakes.

## 3. HOW TO ENTER:

Use InRoads LIVE during sweepstakes period. If Santa randomly answers your visit and you meet eligibility requirements, you win!
